Classification of freelancers

The reason for choosing freelancing as a main activity freelancers need to classify for freelancers who are freelancing because could not find a permanent job, and freelancers who freely chose freelancing as the main activity. For freelancers who are freelancing as are unable to find work, will carry those who want to work, but could not find a permanent job after dismissal or graduation. This reason for choosing freelancing as a main activity may adversely affect the efficiency of their operations, such freelancers may not be pleased with this activity. Such freelancers at the first opportunity to get a job, change the form of employment and prefer to work in organizations where you don't need all the stages of work (search of clients, securing the workplace, and everything necessary for the execution of orders, bookkeeping, etc.) take place independently, and to perform only a designated portion of certain employer's location at a specific time.

Accordingly, the low level of satisfaction from finansovoi activities can positively influence its efficiency. Although for the rest of this category of freelancers, on the contrary, such circumstances can be the impetus for the development of successful entrepreneurial activities in the field of freelancing.

For freelancers who have freely chosen freelancing as their main activity belong to freelancers, which on their own are choosing freelancing as an attractive alternative to wage employment. Part freelancers starting their career after graduation or even during training and has no experience working as a contract employee. Other first work in the organization, gain experience, and when I feel that I will be able to practise their profession and have enough customers become freelancers. Experience the employee has a positive effect on future work in freelance, because during this time, additional training, you receive a wide circle of acquaintances in the sphere of professional activity, regular customers who will stay regardless of whether you work for the same organization, or to do their own thing, that helps us conduct business.

Can also be classified freelancers on the experience of working freelance and the experience of working as a contract employee, since experience affects both the number of customers and the quality of projects and the level of income of the freelancer. Therefore, the experience of working freelance is useful to distinguish freelancers working in this field from more than 10 years to less than 1 year.

The experience of working as a contract employee, we offer you to select freelancers who have worked on the staff of the organization: until now, combined with freelance employment to never worked employees.

According to the survey of freelancers, only 17% of them do not have experience in staff organization, 5.1 percent – worked less than 1 year 9% – 1 to 2 years, and 22.3% of freelancers worked for the employer for over 7 years and 22.9% are still working. Freelancers with extensive experience in state organizations have many advantages in the freelance market because they have more regular customers who will in any case cooperate with them, regardless of where they will fulfill the order. They also have experience of executing various projects, you know the cost of such work and the necessary cost of time, i.e. can the highest possible efficiency to workflow. Freelancers have the necessary contacts in your professional circle, which is also an advantage. Therefore, the confidence of customers to the freelancers is growing along with the increase in experience, and consequently grow revenues.

Freelancers can be classified according to the principle of extraterritoriality for freelancers working in the domestic and the foreign market, or a combination of the previous two types – combined form, that is <u>affordable essay for sale website</u>, freelancers who work “no boundaries”. The reason for the cooperation of freelancers only with customers from their country can be the language barrier, which does not allow to cooperate with foreign customers, the difficulty of signing the contract and payment. The reason for the cooperation with freelancers only foreign customers can be a high level of payment for completed projects.
